### Purpose of the job

The aim of this role is to ensure smooth and efficient operational delivery of the responsive and void repairs service.

# Main areas of responsibility

To undertake inspections to Council owned property (both social rental and corporate property) whether tenanted or void. To diagnose disrepair, issue works orders and monitor contractor performance in the execution of work.

Plan and investigate and recommend use of appropriate building products

Ensure adherence to health and safety requirements around FRA's, asbestos, gas servicing, fixed wire electrical inspection, PAT testing, water hygiene, lift maintenance and other similar in the context of domestic and commercial premises.

Specifically in relation to voids, to ensure void pre and post inspections are undertaken in a timely manner and that contractor performance is monitored to ensure prompt turnaround times are achieved to void property

Monitor, manage contractor performance and attend contractor meetings to build good working relationships
